The newspaper advertisement for the postal ballot was given on Friday, January 17,2025 in Business Standard (English) and Deepika (Malayalam) newspapers respectively.

The voting period for remote e-voting commenced at 9.00 a.m. (IST) on Monday, January 20, 2025, and ended at 5.00 p.m. (IST) on Wednesday, February 19, 2025 and the Central Depository Securities Limited e-voting module was disabled thereafter.

The votes cast under remote e-voting facility were thereafter unblocked at 05.14 pm on Wednesday, February 19, 2025, in the presence of two individuals were not in the rolls of the company

I have scrutinized and reviewed the votes cast through remote e-voting based on the data downloaded from the Central Depository Securities Limited e-voting system and have maintained a register in which necessary entries have been made in accordance with the Companies (Management and Administration) Rules, 2014, as amended.

The Management of the Company is responsible to ensure compliance with the requirements of the Companies Act, 2013, rules and the MCA Circulars relating to remote e-voting on the Resolution contained in the notice of Postal Ballot.
