- 3. In accordance with the Notice of the 29th Annual General Meeting sent to the shareholders and the 'Advertisement' published pursuant to Rule 20(4)(v) of the Companies (Management and Administration) Rules, 2014 (Amendment Rules 2015) on October 7, 2020, the remote e-voting opened at 9:00 AM on October 27, 2020 and remained open up to 5:00 PM on October 29, 2020.
- 4. After declaration of voting by the Chairman, the shareholders present at the AGM through VC voted through e-voting facility provided by CDSL at the AGM.
- 5. The Equity Shareholders holding shares as on October 23, 2020, "cut off date", were entitled to vote electronically on the resolutions stated in the Notice of the 29th Annual General Meeting of the Company.
- 6. As per the information given by the Company the names of the shareholders who had voted by remote e-voting through the facility provided by CDSL had been blocked and only those members who were present at the AGM through VC and who had not voted on remote e-voting were allowed to cast their votes through e-voting system during the AGM.
