Textual Information()

Pursuant to an approved Resolution Plan (RP) for restructuring of Company's Debts, formulated under the principles of the Reserve Bank of India (Prudential Framework for Resolution of Stressed Assets) Directions, 2019 issued by the Reserve Bank of India vide its Circular No RBI/2018-19/203/DBR.No.BP.BC.45/21.04.048/2018-19 dated 7th June 2019, the Company has issued 0.50% 20,51,000 Non-Cumulative Compulsorily Convertible Preference Shares (NCCCPS) of Rs. 100 each aggregating Rs. 20,51,00,000 on 14.11.2022 to the Lenders viz Central Bank of India, State Bank of India, Export Import Bank of India, Punjab National Bank, Canara Bank, Bank of Maharashtra and The Karur Vysya Bank Ltd (10,81,000 NCCCPS of Rs.100 each) and to the Promoters Shri B K Patodia and Shri Umang Patodia (1,00,000 NCCCPS of Rs. 100 each) and Associate of Promoter Smt Deepa Bagla (8,70,000 NCCCPS of Rs 100 each) in lieu of existing Non-Cumulative Redeemable Preference Shares(NCRPS) issued under CDR Scheme. The said NCCCPS will be converted into Equity on 31-03-2030 as per the approved RP.
